Welfare Reform 2013 Advice Guide



The Government has introduced a range of Welfare Reform changes, which will affect many people across Leeds. Unity is required by the Government to action these changes. This leaflet highlights some of the most important changes and gives advice to those affected.

It looks at:

- Under Occupancy
- Discretionary Housing Payments
- Council Tax Support
- Local Welfare Support



Under Occupancy



The Government has introduced some exceptions to the rules regarding under-occupation. You will be allowed a 'spare' bedroom if:

- You need an overnight carer
- You have a spare room as a result of a bereavement in the family, (you will be exempt for 12 months from the date of bereavement)
- You have paid rent for the previous 12 months without claiming Housing Benefit (you will be exempt for 13 weeks)
- You have an adult child or children who are away at university but continue to live with you and intend to return home as long as they are not away for more than 52 weeks.

- You are an approved foster carer, whether or not a child has been placed with you so long as you have fostered a child or become an approved foster carer in the last 12 months.
- You have a child with a severe disability who is unable to share a bedroom with a sibling.
- You have an adult child in the Armed Forces who continues to live with you and intends to return home.

The last three exceptions were announced on 12th March 2013.

Supporting BME Communities

Apply for DHP:

If you are struggling to pay your rent as a result of the under-occupation sanctions, you may be entitled to apply for a Discretionary Housing Payment. These payments are aimed at:

- Tenants where a member of the household is disabled and the property has undergone significant adaptation because of the disability.
- Parents requiring an additional room under child access arrangements where alternative housing options are not appropriate.
- Older people approaching
 Pension Credit age where work
 is not a realistic option.
- Families expecting a first child where a housing allocation has been made on this basis.

If you think you might be eligible, please let us know. We will be able to provide support in making an application.

Move to a smaller home:

- Ask us about a Unity 2 Unity
 Mutual Exchange. You may be
 able to swap with a Unity tenant.
 Moving will be quicker as there
 is no need to bid.
- Register with Leeds Homes to apply for social housing; this is essential if you want to exchange or transfer

Stay and pay:

- Increase your working hours
- Try to save money on bills
- ✓ Get help with budgeting

Council Tax Support



As a result of the changes to Council Tax Benefit, most working age claimants will lost 19% of their Council Tax Support from 1st April 2013. This means that some people will have to pay Council Tax when they did not before.

The following groups are not affected:

- Pensioners anyone who is eligible to claim Pension Credit as at 1st April 2013 (this means anyone born before 5th October 1951) unless you have chosen to claim a working age benefit instead.
- People entitled to a
 Severe Disability
 Premium

- People entitled to an Enhanced Disability Premium
- Anyone entitled to Carer's Allowance

If you think you might be exempt, you should notify Leeds City Council by calling 0113 222 4404.

If you are worried about being able to afford your Council Tax bill, the Council may be able to make an arrangement with you to pay in smaller instalments, or pay weekly or fortnightly.

Local Welfare Support



The Government has abolished Community Care Grants and Crisis Loans for living expenses.

If you require emergency support (budgeting loans and short term budgeting advances) you should contact the Department for Work & Pensions (DWP) on 0845 608 8590.

If the DWP cannot provide support and you require emergency help you can call Leeds City Council to ask for help.

Leeds City Council has set up a Local Welfare Support Scheme to support people who require emergency assistance. The scheme will be based on providing basic household goods and emergency provision

Local Welfare Assistance will not be offered as cash. This is to ensure that the money is spent on the things you need most. Instead:

- Leeds City Council will be providing a voucher scheme.
- Applications will be made online or over the telephone.
- The value of the vouchers will not have to be repaid.

Awards will be made by the following methods:

- ▼ Standard food basket packs delivered direct to you
- ✓ Pre-payment card for food/goods
- ▼ Payments to suppliers of suitable goods or services to be delivered to you

The Local Welfare Support Scheme is to help the most vulnerable, including:

- Families or vulnerable people under exceptional pressure.
- Homeless people or rough sleepers
- ✓ Vulnerable older people
- People fleeing domestic violence
- Young people leaving care or living independently
- People moving out of institutional care into the community
- ▼ Ex-offenders leaving prison or detention centres
- People with disabilities
